- ▶ **Existing Shareholders** – if you wish to sell shares in listed companies, you will now need to submit your Shareholding Statement instead of share certificate. Your stockbrokers will assist you in obtaining the Shareholding Statement.
- ▶ **Future Shareholders** – the share registry now issues Shareholding Statement confirming your investments in the listed company.
